•RICH COULTER-GRABILL FAIR BOARD:

Rich Coulter addressed the Town Council with safety concerns surrounding the Town Insurance and Liability with the delayed road construction of West Street. Where in previous years staging as well as Vendor Tent(s) would be located. Mr. Coulter voiced that the Town could be liable if the Town proceeded with continuing the parade with the ongoing construction due to possible injury by fair goers.

Mr. Coulter asked Todd with DLZ to get into contact with NIPSCO as well as Brooks Construction regarding the delayed work on West Street, for a more definitive answer on the completion timeline for the section of West Street from Main Street to Second Street. This would include the completion of Curbing, Sidewalk, Roadway as well as applied sodding. Conversation with NISPCO and Brooks, will forecast the decision to move forward with the 2024 Grabill Fair.

Signage sample presented to Town Council for approval. Proposed signage approved and passed by Vice President Jeff Smead, seconded by Councilman Wilmer Delagrange. Decision to be forwarded to President Claude E. Schrock to communicate with Platinum Metals of Town Council's approval.

•KYSTEL WILLIAMS:

Letter presented to council asking for credit to be applied to upcoming utility billing due to massive water leak within her residence. The Town Council agreed to review utility billing once billed and assess the necessary credits to be applied to accommodate her situation. The Town Council asked Clerk-Treasurer Stephanie J. Smith to provide this information for further review.
